

MESSAGE **FROM OUR** DIRECTOR

We share with you our Institutional Report of 2020, in which we describe the work we conducted in a year marked by the most serious national and international sanitary emergency produced by COVID-19. In 2020, Promsex celebrated 15 years of institutional life, and despite the difficult context, it continued to contribute with its work in the field of sexual and reproductive rights, gender equality and non-discrimination. This year we also initiated the implementation of the new Institutional Strategic Plan 2020 - 2024, the progress of which will be described in this document.

The sanitary emergency required the shift from face-to-face work to remote work, this was possible after a guick adaptation since Promsex already had platforms enabled for virtual work; however, the new context and the need to not lose relevance in our interventions caused necessary technical and budgetary adjustments to all ongoing projects; maintaining a continuous dialog with donor organizations. Furthermore, the context involved the strengthening of the institutional team to manage methodologies and technologies on a virtual manner.

We continue to develop advocacy actions so that sexual and reproductive health care is guaranteed as an essential service, contributing in the adoption of new regulations, implementing sexual and reproductive health care models with a community element at the first level of health care, and monitoring access to sexual and reproductive health services. Likewise, significant progress and results were achieved in emblematic litigations at both the national and international levels; and we maintained our alliances and participation in several platforms for dialog.

Together with our partner organizations in different regions of the country, we responded quickly to COVID-19 providing protective equipment to health professionals, community promoters of health and the fight against violence; WE CLOSED THE

we provided dignity and protection kits for victims of violence and trafficking, as well as information and protection materials for families through women's organizations.

We were not indifferent to the serious political crisis of 2020, in the midst of the political instability generated by the illegitimate takeover of a group of members of the Congress after promoting and achieving presidential vacancy; we declared our stand publicly calling for the defense of democracy and we joined other groups in favor of an unrestricted respect for human rights in the framework of citizen protests to restore the democratic order in the country.

It was a priority to collectively process the adverse impacts caused by the pandemic. In 2020 we faced the disease, the death of loved ones and mourning in the midst of social distancing and confinement; to this effect, we also had available external psychology and health care professionals to support the institutional team.

We closed the year 2020 as an organization capable of continuing to conduct actions relevant to our country, and with a work team of which we are very proud.





WE DEVELOPED THE VIRTUAL SCHOOL EMPODERA 2020:

FOR LGBTI LEADERSHIP IN PARTNERSHIP WITH THE NATIONAL ELECTORAL BOARD

The Empodera school developed in partnership with the National Electoral Board (JNE) and with the support of the European Union (EU), Hivos and The Victory Institute, has contributed to the civic engagement and citizen participation of the LGBTI population, in a context of crisis not only in the health sector, but also of political representation in the country, and prior to a presidential and congressional electoral process.

It promoted the achievement of 3 results. The first one to strengthen LGBTI leadership, through the acquisition of knowledge, skills, abilities and attitudes for a successful citizen participation. The second one for the adoption of effective strategies to compete in electoral processes, to cause a political impact, to strengthen civil society organizations, to speak publicly and to increase the safety of human rights defenders. And the third one to promote the articulation of networks and alliances between the participants and their political and social organizations for the defense of the human rights of LGBTI people.

The experience developed during 2020 has demonstrated the importance of this strategy, which, despite being conducted in a virtual manner due to the context of sanitary emergency, achieved the candidacy of 349 people, an amount higher than previous versions of Empodera.

OSITRAN'S DECISION

CASE OF JUNIOR ANTONIO GÁLVEZ SALAZAR

Ositran declared the appeal admissible, and ordered LAP to elaborate a manual submitted and to train its agents. The supervisory body noted in the decision that it has not been proved that Lima Airport Partners, operator of the Jorge Chavez International Airport, has provided a quality service, and therefore, it ordered corrective measures to prevent these acts of discrimination from happening again in the future.

The decision states that "entities providing public transportation infrastructure services cannot remain indifferent to the commitment to provide an adequate quality service, which allows people to remain safely inside. In light of this, the institutions must implement actions to eradicate discriminatory acts and practices that may be committed in their premises."

The Court ordered LAP to comply with the following corrective measures:

* Develop a service guide or protocol specifying inappropriate behaviors or misconduct by the users that could warrant the intervention of the

airport security personnel, including cases of verbal or physical assault against other users affecting their dignity and safety.

* Conduct periodic training for the security personnel in order to disseminate the guide and raise awareness on the importance of the timely identification of this type of unwanted behavior to stop it immediately.

Likewise, in the framework of this process, LAP was sanctioned by the Provincial Municipality of Callao for non-compliance with the ordinance against discrimination.

SENTENCE IN THE CASE OF AZUL ROJAS AGAINST THE PERUVIAN STATE

INTER-AMERICAN COURT OF HUMAN RIGHTS

Promsex, in co-litigation with the National Coordinator of Human Rights and Redress, achieved a historic sentence in the case of Azul Rojas Marín, in the first case of sexual violence against an LGBTI person, and in particular toward a trans woman, to reach this international instance.

The Inter-American Court of Human Rights found the Peruvian State responsible for torture and sexual violence against an LGBTI person and sentenced it to fight discrimination. This is the first time in history that the Inter-American Court of Human Rights, the highest in this subject in the Americas, considers a case of torture on the grounds of discrimination, and hence the relevance of this sentence.

The historic and unanimous sentence of the Court considers that the detention of Azul Rojas was illegal, arbitrary and motivated only by her sexual orientation and gender expression.

In its ruling, the Inter-American Court of Human Rights not only ordered the

Peruvian State to redress the damage to Azul Rojas Marín, but also urged it to implement measures to officially register cases of violence against LGBTI persons, to effectively investigate these cases, and to sensitize its officials and agents regarding the rights and treatment of people in this group, and the eradication of prejudices in the country.

The Inter-American Court of Human Rights reiterated that "LGBTI people have been historically victims of structural discrimination, stigmatization, several forms of violence and violation of their fundamental rights," and that the sexual orientation, gender identity or gender expression of an individual are categories protected by the Inter-

American Convention on Human Rights.

IMPLEMENTATION OF A FIRST-LEVEL COMMUNITY CARE MODEL IN THE DISTRICT OF VILLA EL SALVADOR IN THE CONTEXT OF THE PANDEMIC

In the framework of an Interinstitutional Agreement with DIRIS Sur, we initiated in a coordinated manner in the RIS of Villa El Salvador, the implementation of the first-level care model in the CMI Juan Pablo II of Villa El Salvador. With the objective of ensuring the continuity of care for sexual and reproductive health services.

This model aimed to maintain sexual and reproductive health services as essential services, developing strengthening actions with health providers and community promoters, having achieved:

The articulation with the CMI Juan Pablo II Promoters Organization after training 14 of its members on protective measures against COVID-19, family planning, work with pregnant women, gender-based violence, and a family record to determine the needs of the population.

Resuming the field work of the promoters, through the use of 780 family records which allowed us to know the impact of the pandemic on the discontinuity of the access of women to pregnancy monitoring services, access to contraceptive methods, access of adolescents to differentiated services, among others.

Strengthening the capacities of 31 health professionals on the subjects of sexual and reproductive health, and prevention of teenage pregnancy.

SUCCESS STORY

COMMUNITY INFORMATION CENTERS (COC) IN MADRE DE DIOS AS PART OF THE RESPONSE TO THE PANDEMIC

In the framework of the sanitary emergency due to COVID-19, in Centro Poblado Menor Santa Rosa of Madre de Dios, we worked with the healthcare sector to support the continuity of essential services for girls and boys offered by the Santa Rosa Health Post. Due to the impossibility to establish in a differentiated manner health care circuits for COVID and not COVID, we made available the COC facilities of Santa Rosa for the development of the Children Health Care and Monitoring Program, complying with all protocols established by the Government.

Thus, the Health Post was able to implement a non-COVID health care circuit and continue with its program, performing 427 services for girls and boys with weight and height control, anemia control and vaccinations.

Community promoters in charge of the COC of Santa Rosa, as well as the COC of La Joya, performed 78 services mostly over the telephone providing counseling and guidance on several issues related to violence, sexual and reproductive rights, raising children in times of pandemic.

The cases that required specialized counselling and care were referred in a timely manner to health centers, Emergency Centers for Women, or other specialized institutions, with the corresponding follow-up of these cases.


